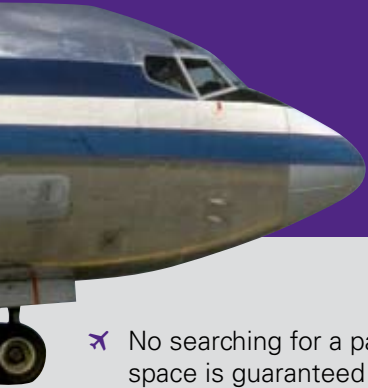

Terms And Conditions

Rates effective May 1, 2009 (subject to change on not less than sixty days notice): \$10 first hour, \$25 flat rate per 24 hours

Applications for BizPark will be accepted on a first-come, first-served basis, subject to parking space availability.

Parking space within the BizPark area is guaranteed to BizPark members.

Transponders will be provided to BizPark members upon registration and credit approval. A \$40 deposit for the transponder will be charged to the user's credit card. This deposit will be refundable upon cancellation of account and return of transponder. Malfunctioning transponders will be replaced free of charge except where caused by damage or misuse. Replacement of lost or damaged transponders will carry a \$50 charge.

All vehicles parked in the BizPark area are parked at owner's/driver's risk. The Ottawa Macdonald-Cartier International Airport Authority and the parking operator (currently Imperial Parking) assume no responsibility or liability whatsoever for damage or loss due to fire, theft or otherwise to vehicle or its contents, however caused.

Parking charges are for use of the BizPark parking area in the Airport Parkade and shall be based strictly on usage as recorded by the automated vehicle identification system and billed directly to the users credit card number on file. A detailed monthly statement of usage will be provided.

If there has been no activity on an account for 12 months or more, the transponder will be deleted from the system. The \$40 dollar deposit will be retained by the Airport Authority until such time as the transponder is returned to the Parking Administration Office.

BizPark members agree to pay for use of BizPark and to inform the Parking Administration Office in person on level 0 of the Parkade, or by telephone at (613) 248-2000 ext. 1135, of any change in personal or credit card information.

Member personal data (including credit card information) will be used strictly and exclusively for the BizPark operation and will not be used or sold to any other company or organization for any purpose whatsoever.
